This puts the developers before the community, means that we lose an existing asset, the car park, which is crucial not only to the future of the building as a cultural and community centre but also to the future of the livelihood of small businesses like mine in Crouch End. Judy Bax's plan will give us 'development' all over the car park. I imagine the building – 'only' four storeys high – will look not unlike a tower block lying on its side.

By not protecting the car park and recommending pay and display facility, visitors and shoppers in Crouch End will find it increasingly difficult to frequent our shops and businesses including Mr. Freeman's bakery. As for me, I don't think the cakes and Dunns will ever taste quite the same again.

Residents in the area have been more than patient, recognising that the new facilities are for the benefit of all, but their sufferance may well be exhausted by the time it takes to rescue the project and finish the works. The 'P' in PFI stands for 'Private' but in the light of the Whittington's experience, 'Perilous' seems a more appropriate description.

Looking for positives

THERE are two sides to every story. Last week a Crouch End for People representative on the Hornsey Town Hall advisory panel slammed the 'bullying' stewardship of Cllr Judy Bax. This week a dozen panel members say the reverse is true and that Cllr Bax has always been even-handed and accommodating.

Ordinary people with a keen if not obsessive interest in the future of the site must wonder where the truth lies. It would have been surprising, giving the strength of feeling on the issue, had the panel agreed unanimously on everything. But things have moved on and as in every conflict situation, the emphasis now should be on finding common ground and exploiting the positive things that have emerged from the process, rather than constantly dwelling on the negatives.
