AN I make it absolutely clear that Haringey Council is committed to a sustainable future for Hornsey Town Hall and is well aware of the significance of this important building, for Crouch End and the borough as a whole.

All views and ideas are being considered, and the advisory panel, made up of representatives of local organisations, local councillors and residents, is one way of helping us forward. It is looking at the various uses proposed for the site, and ways to pay for them.

The points made in the Crouch End for People petition are also being considered, along with all the views expressed by visitors to the town hall open days. As with any large project, there will be many stages of consultation along the way, coupled with scrutiny by English Heritage and in accordance with the developing criteria of the planning brief.

The worst result would be to let the situation drift; I am convinced that everyone with an interest in the building can work together to stop that happening. The second open day is scheduled for July 10, 10.30am to 3pm, and I hope everyone who has not yet seen the building will take the opportunity to look around and give us their views.
