switched on, the grass area tidied up. Drunks who had fallen asleep on their usual benches were seen to rub their eyes in disbelief when they awoke!

The Party in the Piazza, to which thousands flocked, was organised flawlessly by Crouch End for People in very difficult circumstances. Sponsored by local businesses – Budgens, Winkworths and Dunns – it was a radiant day. Crouch End for People demonstrated that, with

organisation and spirit, the Town Hall frontage could indeed very easily become a piazza.

The point is this. If Haringey Council is already pledging that the Town Hall Theatre is to be returned to community use, and there is now a serious case for the entire site to be given back to the community, then it is imperative that the community organisation that runs it is competent or we will be back to square one.

It would be a nightmare for Haringey to retain organisation and ownership of the town hall. They are not to be trusted and they have no organisational skills.

Neither do they have the support of local people.

Crouch End for People, on the other hand, have shown time and again that they deliver and they have both the organisational skills and support of local people — 3500 at the last count — far more than the total number of people who voted in Crouch End at the last election!

Why was Judy Bax so critical?

WONDER what in particular provoked Cllr Judy Bax's intemperate remarks about Crouch End for People (Olive branch offered in battle for town hall, H&H Broadway, June 18).

Crouch End for People is not working against the council, nor criticising it for the sake of criticising. Indeed, we want very much to work with the council.

What I think she hasn't quite accepted is that Crouch End for People is putting forward a coherent, holistic and professional plan for the development of the site, one which is tailor-made to fit the needs of the community, the people of the borough and of London as a whole. I urge her to read the plan, which is available at www.crouchendforpeople.org/docs/development%20Brief.pdf.

Her remarks show a regrettable lack of knowledge of Crouch End for People's proposals. Crucially, she mentions that the town hall site might be administered by a trust. Crouch End for People has already set up a trust for the funding and management of the site, Hornsey Town Hall Trust Ltd.

She seems immovably fixed in the belief that the site should be entrusted to a commercial developer. I sincerely hope she can be persuaded to change her mind.

I strongly disagree with her that in the present deliberations over the future of the town hall, "the only argument was about funding." There is a clear difference between Crouch End for People's tailor-made plan and the council proposals, which favour intensive development with no consideration of the full spectrum of social needs in and around Crouch End.

Town hall panel is unrepresentative

read the interview with Councillor Judy Bax about Hornsey Town Hall with a sense of dismay. It appears that she doesn't consider Crouch End for People a valid organisation that represents local interest. I have lived in Crouch End for over 20 years and the town hall campaign organised by CEfP has generated more genuine interest and concern than any other issue I can remember.

CEfP is the only organisation that has presented proposals to the local population, with open meetings inviting discussion.

Clearly, having more than one CEFP member appears threatening to the council. Such an attitude can only raise the suspicion that the council is keen to dispose of the town hall to the highest bidder with scant regard for the wishes of the local population. That the future of the town hall remains in the hands of this unrepresentative panel is an affront.

Council leader Charles Adje has stated that it isn't the intention to sell the site to a developer, but to lease it for 125 years. Does he really think we are so stupid as to think this is not a sale? At the recent CEfP meeting he also stated his willingness to open the books, in order for CEfP to better understand the renovation costs involved. That he has failed to honour this agreement can only sow deeper suspicion that the council has no serious wish to take local opinion into account.

Crouch End tigers hit on 'dragon'

THE Broadway postbag took a pounding this week as supporters of Crouch End for People reacted angrily to an intended 'olive branch' approach from Cllr Judy Bax, who heads up the advisory panel discussing the future of Hornsey Town Hall.

In dozens of letters, not all of which could be printed, they have been crying 'foul' over her suggestion that the organisation seems determined to work against Haringey Council. It was an unwise allegation which has served only to confirm Cllr Bax as their 'bete noire'.

Small wonder that she and other members of the advisory panel decided to take a night off and watch the decisive England v Croatia football match on Monday.

In Portugal, disputes were settled in a little over 90 minutes it will take much longer to unravel the complexity of the town hall negotiations. And time is running out.

It is unfortunate that the debate is now taking place against a background of hostility and animosity.

Trust, that essential ingredient for meaningful discussion, has gone absent – if it was ever present in the first place.

Cllr Bax has become the archetypal dragon in what CEfP see as the battle between what is good and what is bad for Crouch End. But it is in everyone's interest that fences are mended and that constructive debate re-emerges from the acrimony.

The same could be said of the traffic calming battle in Muswell Hill, where residents in adjoining streets are at war with each other, instead of concentrating on dissecting Haringey Council's flawed proposals.

The two options seem designed to pit resident against resident, and if the council's intention is to "divide and conquer" it must be delighted by its success.

Neither of the council's options will solve problems in one area without transferring them elsewhere. The residents should say an emphatic 'no' to both, and send the traffic mandarius back to the drawing board.
