
The Friends of Red Gables deserve all the support we can give them as they fight to save this centre and remember that Crouch End For People is still going strong.

They continue to work with The Hornsey Town Hall Trust to secure a better future for the town hall. They still need everyone's involvement if they are to succeed.

But Homsey Town Hall could soon be in the clutches of a developer and by the summer Haringey must reveal how much of the site will be given up for flats and how little will be left for the community.

It seems absurd that Haringey is now advertising for local people with appropriate skills to come forward and join their 'community partnership' when The Hornsey Town Hall Trust, who represented an overwhelming majority of the community, offered all the skills, imagination and expertise that any council could want

Their skills were worth far more than Haringey could ever afford to pay but were



rejected, without regard.

This could be the ideal opportunity for the Hornsey Town Hall Trustees to make a valuable contribution to the project but somehow I don't imagine the council will be interested. If anything, they will actively exclude the trustees because they have an opposing vision to their own.

Certainly, the only community partnership Haringey Council is willing to create is one involving those who collude with their money-making priorities – leaving our town hall to stand as a shadow of the vision that might have been.

Could the council instead not genuinely listen to the views of the local people?

## Fate of Wood Green landmark serves as timely warning

ROUCH End for People has consistently opposed the council's proposed sale of the Hornsey Town Hall site to 'a preferred developer'. You only have to look to Wood Green over the past few weeks to see why.

The council's property service department has demolished Wood Green's oldest building, the Congregational Church, to pave the way for a massive development of flats.

Given the high density now allowed by Haringey's new Unitary Development Plan of 700 habitable rooms per hectare, the way is paved for the developers to submit a scheme of two blocks of six and nine stories apiece, and this has understandably shocked Wood Green residents.

What is to stop a similar development at the rear of the Town Hall? The area of the car park is about the same (0.25 hectares), but the overall site is much larger at 1.29 hectares. The developer could erect two bulky10-storey blocks (the same height as the town hall tower) with the council's blessing.

There is a simple way to avoid going down this route. The Hornsey Town Hall Trust, using the funds donated by countless local people, have prepared a detailed business plan showing how the whole site can be put to sustainable use whilst preserving all the public amenities that this fine building was endowed with.

This plan can be found on the trust's website (www.hornseytownhall.org). Richard Milner told the executive in December that the plan would be looked at along with other bids for the site, yet this was not minuted by Haringey. This spring will see tireless campaigning and a further public meeting to back our bid.
